2. The documents presented by the Management of your

the District Education Officer (Senior Secondary School) Amritsar  
and D.P.I. Private aided (School) after taking into consideration  
the No Objection certificate has been issued by the Punjab  
Government on the following terms and conditions.

1. That in future on any complaint/after conducting the  
inspection if come to the notice that you have given  
false application for obtaining No Objection certificate  
and you have not implemented the instructions issued by  
the Punjab Government from time to time and you have not  
abided the written conditions mentioned in the affidavit  
and in that case No Objection Certificate can be taken  
back.
2. That it will be compulsory to teach Punjabi upto  
10th class and C.B.S.E New Delhi will make proper  
arrangement for taking the examination of Punjabi and  
with this it is also stated that for non compliance the  
No objection certificate will be taken back immediately.

3. After obtaining the affiliation of C.B.S.E. New Delhi the Management of the School will pay salary and other allowances such like Punjab Government employee to the Teaching Staff and Non Teaching Staff and for non compliance the No objection certificate will be taken back immediately.
4. You yourself and your Management it will ensure that if any time your District Education Officer or from the Education Department from any Senior Officer any kind of information is asked for then the same will be got available to them and necessary cooperation will also be provided.
5. Whereas after the receipt of Affiliation from C.B.S.E. New Delhi affiliation obtained from Punjab School Education Board Mohali will be got cancelled from them.

This approval has been issued as per order of Hon'ble Education Minister vide his order dated 29.1.2008.
